Providing documents (Packing list, Invoice, Customs declaration form). Packing list (including: Consignor and consignee, Description, Customs code, quantity, Packing, Gross weight and net weight) , receive_order_name, Invoice (including: Consignor and consignee, Description, Customs code, quantity, Unit price, Amount, Gross weight and net weight) , EX (including: (Declaration number, Total gross weight, Packing, Customs code besides Saturday and Sunday.)

Note : According to China customs regulations, please ensure the seal be locked at the 3rd Lock Handle with round rivet on the locking device of the container rear end (from left to right). Please to Mark 3 on the pictures below.

Warning: A. Weight limit of the cargo in a 20' container is 21 tons. Weight limit of the cargo in a 40' container is 23 tons.

A. 20尺柜货重限重21吨，40尺柜货重限重23吨。

B. If the single piece of cargo weighs more than 100KG, packaging details and loading photo must be provided. The container stuffing plan can be accepted only after the confirmation from ZIH.

B. 单件货重超过100KG, 装箱前需提供包装明细和装箱照片。经陆港公司审核并符合铁路要求的，依照此方案进行装箱。

C. Security requirements of railway transportation: Cargo's center of gravity should be placed in the center of the container. Unbalance loading and over loading is unacceptable, for example, one side of the container is heavier than the other side, or one end of container is heavier than the other end. If the container is unbalanced or over loaded, we will need to do the container stuffing again. The related unstuffing and stuffing fees (Resulting in an additional operating cost of 150 dollars) incurred shall be at the booking party's cost. If there is a shift packing of goods, dumping, spilling and other safety hazards, the goods reinforcement must be handled in accordance with the requirements of ZIH and ZIH can provide on-site technical packing service.

C. 铁路运输安全要求：货箱重心必须居中，绝对不能偏载、偏重、超重。不可出现货箱一头重一头轻或者一侧重一侧轻的偏载现象。如发生以上偏载、偏重、超重现象，必须将货物掏出来重新装箱，所产生的掏、装箱等相关费用（导致额外的操作成本为150美元），由订舱方自行承担。若装箱货物存在移位、倾倒、溢出等安全隐患的，必须按照陆港公司的要求对货物进行加固处理，我司提供现场装箱技术服务。

40尺开顶箱：2个侧壁，每侧侧壁4个锁杆需要4个锁具，每侧箱顶需要3个锁具，箱门需要1个锁具。一共15个

20尺开顶箱：2个侧壁，每侧侧壁2-3个锁杆需要2-3个锁具，每侧箱顶需要2个锁具，箱门需要1个锁具。一共是9个或者11个

400T: Two sides, four locks on each side, 3 locks on the container top of each side and 1 lock on the door, totally 15 locks.

200T: Two sides, 2 or 3 locks on each side, 2 locks on the container top of each side and 1 lock on the door, totally 9 or 11 locks.

1) Keep balance of FRONT and BACK
For general cargo, separated by the central line (Top view of a container), different value of each side should be less than 200kg.
2) Keep balance of LEFT and RIGHT
For general cargo, separated by the central line (Top view of a container), different value of each side should be less than 500kg.

Kindly reminder:
1. Please load the container according to above requirements, otherwise the full container may be unloaded from the train on the way, or be shifted again or be detached from the train back track.
2. Heavy cargoes: load-bearing of per area < 110kg/m², please increase the contact area between the floor and cargoes when loading the container. To avoid damage or destroy the container floor and bottom side rail.
3. Before picking up the container please inspect the condition. When unloading the cargoes please sweep up the debris in the container, such as wood blocks, packaging, shavings.





Note :Please deliver the bulk cargo to the designated terminal with this document and hand it over to personnel in terminal.
